WAIVER AND RELEASE OF LIABILITY FORM

Please note: read this document carefully. With this declaration, you waive your rights in case of damage. By signing, you declare that you waive your rights towards Race Planet Amsterdam, Race Planet Delft, Race Planet Zandvoort and its affiliate companies (hereinafter referred to as "BRP"), including the any third parties contracted by BRP, and you accept this.

1. Racing, driving on the circuit and go-karting are highly dangerous activities!

1.1. You declare that you are aware that participation in BRP activities and entry to the location of these activities increase the risk of damage. When participating in or visiting an activity, damage may occur for example due to pilot errors, collisions, cutting off or due to carelessness or failure of (fellow) participants. There is an increased risk of damage resulting from death. You accept this increased risk and expressly take responsibility for it.

1.2. By signing this form, you waive your right to bring a claim against BRP, its employees, instructors, management and third parties contracted by BRP to carry out its activities, like Exploitatie Circuit Park Zandvoort B.V. and Bridgestone Europe NV/SA, in the event that you suffer damage. Your release of liability concerns damage of any kind, including injury or damage resulting from death, which may occur as a result of participation in, a visit to an activity or as a result of the use of facilities or services offered by BRP or third parties contracted by BRP.

2. Instructions, requirements and safety regulations

2.1. It is your own responsibility to receive an explanation or instruction, to pay attention during the explanation and that you abide by instructions, including safety and house regulations. You are obliged to request an explanation when you are not provided with one, when you fail to attend the explanation or when you fail to understand it. BRP employees are present for support, but their presence does not guarantee that calamities or accidents can be prevented. You must keep a good eye on the tracks, the (parking) spaces and other participants.

2.2. You are obliged to wear the designated safety gear, including a helmet. Long hair must be tucked away under the helmet. The helmet must fit well and be secured before you start the activities. It is your own responsibility that this happens.

2.3. You declare that you are aware that an explanation, instruction or requirement does not guarantee the prevention of calamities, damage, tangible/intangible, including injury. By signing this form you waive BRP and third parties contracted by BRP, in case of any damage that may occur.

3. Vehicles and participation with own vehicle

3.1. When you participate in a BRP activity with your own vehicle, you are responsible for the (technical) state, maintenance and capacities of the vehicle, including the way it is driven. Participation with your own vehicle is entirely at your own risk.

3.2. With regard to the vehicles that BRP uses during its event, BRP will do everything in its power to comply with mandatory inspections, fire safety, licenses, technical maintenance etc. You realise that parts, including a wheel or the steering wheel, can break apart, the brake may fail, and the engine /fuel tank /pipes / fuel /oils may catch fire, with all the consequences that this entails. BRP cannot guarantee that the vehicles operated are free of defects. You realise the afore-mentioned and accept this risk.

3.3. By signing this form, you waive your right to bring a claim against BRP, its employees, instructors, management and third parties contracted by BRP, in the event that you suffer damage of any kind, including injury or damage resulting from death, which may occur as a result of the use of a vehicle during an activity and/or in the event that you participate with you own vehicle or in the event that you collide with another vehicle on the circuit, the tracks, the course and/or the related (parking) spaces.

4. Health risks of participation

BRP activities are strenuous. Therefore, you must be in good shape. Participation is prohibited in case you suffer from neck or back pains, are pregnant, suffer/ suffered from a heart condition, are in bad shape, are short of breath, are under the influence of medicine, drugs and/or alcohol or in case you have mental and/ or physical defects or injuries. It is your responsibility to assess whether you can or cannot participate. You cannot hold BRP liable in any way.

5. Damage to properties or third parties and deductible

5.1. In case of reckless driving, collisions, cutting off of other drivers, driving against road blocks, destruction of property etc. the counterparty, BRP or third parties, including other participants, can hold you liable for all damage suffered. BRP is not in any way liable for damage and/or injury inflicted by other participants.

5.2. You are obliged to abide by all instructions and regulations during the participation in activities. If you fail to comply, BRP has the right to exclude you from participation, without restitution of participation fees, and hold you liable for any damage. If you failed to comply with the instructions and regulations, then you will need to reimburse the damage to people or properties that occurred by your hand at and/or around the location of the BRP activities. You will indemnify BRP for any claims from people who visit BRP activities through you.

5.3. In case you inflicted damage to BRP vehicles, in spite of your compliance with instructions, without driving/behaving recklessly, BRP will not hold you liable for any inflicted damage, but when damage occurs during activities on Circuit Zandvoort, you will owe a personal contribution of € 250,-.

6. Applicability General Conditions

The BRP General Conditions apply on the contract and are included. You can also read these on www.raceplanet.com and shall be sent to you free of charge, upon your request. You declare that you have read and agree with the content of the general conditions. This release form shall at all times take precedence over the content of the General Conditions.

7. Declaration valid driving license B (not applicable to go-karting)

You declare that you hold a valid driving license B and that your driving license has not been suspended.
