

WAIVER AND RELEASE OF LIABILITY FORM

Note: Please read this form carefully. This is a statement that you waive your rights if you are harmed. By signing, you declare that you waive your rights against Race Planet Amsterdam, Race Planet Delft, Race Planet Zandvoort and their affiliated companies (hereinafter: "BRP"), including third parties engaged by BRP, and you accept this.

1. Racing, circuit driving and karting are very dangerous activities!

1.1. You declare that you are aware that participation in BRP's activities and entering the location of these activities carries an increased risk of damage. When participating in or visiting an activity, damage can occur due to, for example, steering errors, collisions, cutting off or due to careless actions or omissions by (fellow) participants. There is an increased risk of damage, including serious damage, such as bodily injury or damage resulting from death. You accept this increased risk and expressly assume this risk.

1.2. By signing this form you waive your right to file a claim against BRP, its employees, instructors, management and the third parties that BRP engages in its activities, such as Exploitatie Circuit Park Zandvoort B.V. and Bridgestone Europe NV/SA, if you suffer damage. Your waiver covers damages of any kind, including injury or damage resulting from death, incurred as a result of participation in, attendance at any BRP activity, or use of any of BRP's facilities or services. BRP or third parties engaged by BRP may arise. This indemnification applies under all circumstances, of which only the situation that there is intent or willful recklessness on the part of BRP is excluded.

2. Instructions, regulations and safety rules

2.1. It is your own responsibility to receive an explanation or instruction, to pay attention during the explanation and to comply with regulations, including safety and house rules. You are obliged to ask for an explanation if it is not given, if you miss or do not understand the explanation. BRP employees are present for support, but this does not guarantee that calamities or accidents can be prevented. You must keep a close eye on the track, (parking) areas and other participants.

2.2. You are required to wear appropriate safety gear, including a helmet. Long hair should be tucked under the helmet. The helmet must fit properly and be secure before starting the activities. It is your own responsibility that this happens.

2.3. You declare that you are aware that an explanation, instruction or regulations do not guarantee that calamities and damage, material and/or immaterial, including personal injury, will be prevented. By signing this form you indemnify BRP and third parties engaged by it for any damage that may arise.

3. Insurance and health insurance

3.1 You are obliged to take out adequate insurance, including liability and health insurance. The consequences of inadequate cover are for your own account and risk.
3.2 By means of this statement you waive the right to compensation for damage of any nature whatsoever, including serious damage such as injury or death (see also Article 1.2). You also waive the right to compensation for indirect damage, such as medical expenses (including personal contribution), wage costs, lost profit, etc.

4. Vehicles and participation with own vehicle

4.1. If you participate in a BRP activity with your own vehicle, you are responsible for the (technical) condition, maintenance, capacities and the way of driving your vehicle. Participation with your own vehicle is entirely at your own risk.

4.2. With regard to vehicles used by BRP at its event, BRP will make every effort to comply with mandatory inspections, fire safety, permits, technical maintenance, etc. You realize that parts, such as a wheel or steering wheel, can break off, the brake may fail, the engine/fuel tank/pipes/petrol/oils may catch fire with all the consequences that entails. BRP cannot guarantee that the vehicles used are free of defects. You realize the aforementioned and accept this risk.

4.3. By signing this form you waive your right to bring a claim against BRP, its employees, instructors, management and the third parties engaged by it, if you suffer any damage of any kind, including injury or damage to as a result of death, which arises as a result of the use of a vehicle for an activity and/or if you participates in your own vehicle or if your vehicle is driven by a BRP employee/instructor or if you collide with another vehicle on the circuit, the track, the course and/or the associated (parking) areas.

5. Health risks when participating

BRP's activities are strenuous pursuits. You must therefore be in good shape. Participation is not allowed if you suffer from neck or back problems, are pregnant, have or have had heart problems, are in poor condition, are short of breath or have mental and/or physical defects or complaints. It is your own responsibility to decide whether or not you can participate. Participation is not allowed if you are under the influence of medication, drugs and/or alcohol. You cannot hold BRP liable in any way for this.

6. Damage to property or third parties and excess

6.1. In case of reckless driving, colliding, cutting off, driving into the track barrier, causing destruction, etc., the opposing party, BRP or third parties, including other participants, can hold you liable for all damage suffered. BRP bears no responsibility whatsoever for damage and/or injury caused by other participants. BRP has the right to exclude you from participation, without refund of participation costs.

6.2. You are obliged to comply with all instructions, directions, regulations when participating in activities. If you do not comply with this, BRP has the right to exclude you from participation, without refund of participation costs and to hold you liable for any damage. If you have not complied with the instructions and regulations, you must compensate damage to persons or property that you have caused on and/or around the location of BRP's activities. You indemnify BRP against claims from persons who visit BRP activities through you.

6.3. If you have caused damage to BRP vehicles while all instructions have been properly followed and you have not driven/showed behavior recklessly, BRP will not hold you liable for any damage, but you will be liable if damage occurs during activities on the site. Zandvoort circuit does owe a deductible of €750 (if age between 18 and 25 years) or an amount of €500 (if age 25+ years).

7. Applicability of General Terms and Conditions

BRP's General Terms and Conditions apply to the agreement and are included. You will also find these on www.raceplanet.nl under general terms and conditions and will be sent (free of charge) on request. You declare to have read and agree to the contents of the General Terms and Conditions. With regard to liability, this indemnification always takes precedence over the content of the General Terms and Conditions.

8. Statement valid driving license B (not applicable for karting)

You declare that you are in possession of a valid driving license B and that your driving license has not been withdrawn or denied.

The Dutch text of the indemnification is always decisive for its interpretation.
